***Meet our September 2013 Speaker***

**Republican Party of Texas Chairman**  
**Steve Munisteri**

Steve Munisteri was elected Chairman of the Republican Party of Texas on June 13, 2010. Munisteri defeated the incumbent State Chairman, Ms. Cathie Adams. Munisteri's election marked the first time in modern history that a challenger defeated a sitting incumbent at the state convention. Munisteri was reelected in June 2012. Out of the 9,000+ delegates registered at the time of the 2012 convention vote, only one voted against him.



He began working as a volunteer in Republican campaigns in 1972. His first campaign activity was as a block walker for Hank Grover. Munisteri became very active in the conservative movement having first formed a conservative club at Memorial High School in Houston before going on to become the State Chairman of Texas Young American's for Freedom from 1977-1980, a member of the National YAF board, founding Chairman of the Young Conservatives of Texas, and State Chair of Young Texans for Reagan during the 1980 presidential campaign.

Munisteri obtained a BBA in Finance with Honors from the University of Texas in 1979 before going off to earn a Juris Doctorate of Law from the University of Texas Law School in 1981. Upon graduation from law school he obtained an associate position with the Insurance Defense firm Funderburk and Funderburk. After 13 months at Funderburk and Funderburk, Chairman Munisteri founded the law offices of Stephen P. Munisteri on November 1, 1982 as a one person operation. He built the firm up to a 49 employee, 20 attorney firm which he agreed to sell to a group of his employees in 2004. The sale was completed in 2008 and Munisteri retired at the end of that year. He currently works full-time as the Chairman for the Republican Party of Texas.
